



Rain and Driving

The following information was provided by SOAI Member Barbara Bullinger.

GOOD VISION IN A DOWNPOUR

#1: How to easily achieve good vision while driving during a heavy downpour...

We are not sure why it is so effective; just try this when it rains heavily. This method was told by a Police friend who had experienced and confirmed it.

Note: It is useful, even when driving at night. Most of the motorists would turn on HIGH or FASTEST SPEED of the wipers during heavy downpour, yet the visibility in front of the windshield is still bad... Don't do it. Listen:

In the event you face such a situation, just try your SUN-GLASSES (any model will do), and miracle of miracles occurs! All of a sudden, your visibility in front of your windshield is perfectly clear, as if there is no rain.

Make sure you always have a pair of SUNGLASSES in your car, as you are not only helping yourself to drive safely with good vision, but also might save your friend's life by giving him this idea. Try it yourself and share it with your friends!

Amazingly you still see the drops on the windshield, but not the sheet of rain falling!

You can actually see where the rain bounces off the road. It works to eliminate the blindness from passing semi's spraying you too. Or the "kick-up" if you are following a semi or car in the rain.

They ought to teach that "little" tip in driver's training... It really does work!

#2:

This warning is another good one! I wonder how many people know about this.

A 36 year old female had an accident several weeks ago and totaled her car. A resident of Kilgore, TX and she was traveling between Gladewater & Kilgore.

It was raining, though not excessively, when her car suddenly began to hydro-plane and literally flew through the air. She was not seriously injured but very stunned at the sudden occurrence!

When she explained to the highway patrolman what had happened he told her something that every driver should know - NEVER DRIVE IN THE RAIN WITH YOUR CRUISE CONTROL ON. She thought she was being cautious by setting the cruise control and maintaining a safe consistent speed in the rain.

But the highway patrolman told her that if the cruise control is on when your car begins to hydro-plane and your tires lose contact with the pavement, your car will accelerate to a higher rate of speed making you take off like an airplane. She told the patrolman that was exactly what had occurred.

The patrolman said this warning should be listed, on the driver's seat sunvisor -NEVER USE THE CRUISE CONTROL WHEN THE PAVEMENT IS WET OR ICY, along with the airbag warning. We tell our teenagers to set the cruise control and drive a safe speed - but we don't tell them to use the cruise control only when the pavement is dry.

The only person the accident victim found, who knew this (besides the patrolman), was a man who had a similar accident, totaled his car and sustained severe injuries.

Some vehicles, like the Toyota Sienna Limited XLE, will not allow you to set the cruise control when the windshield wipers are on. Good for Toyota. Other car manufacturers should integrate this life-saving feature.

Ham 'n Cheese Omelet Bake

Ingredients:

1 box (10 oz) Green Giant® frozen broccoli & cheese flavored sauce
1 can (10.2 oz) Pillsbury® Grands!® Flaky Layers refrigerated original biscuits
10 Eggland's Best eggs
1 1/2 cups milk
1 teaspoon ground mustard
Salt and pepper, if desired
2 cups diced cooked ham
1/3 cup chopped onion
1 cup shredded Cheddar cheese (4 oz)
1 cup shredded Swiss cheese (4 oz)
1 jar (4.5 oz) Green Giant® sliced mushrooms, drained

Preparation:

- Heat oven to 350°F. Cut small slit in center of broccoli & cheese sauce pouch.

Microwave on High 3 to 4 minutes, rotating pouch 1/4 turn once halfway through micro-waving. Set aside to cool slightly.

- Meanwhile, spray bottom only of 13x9-inch (3-quart) glass baking dish with CRISCO® Original No-Stick Cooking Spray. Separate dough into 5 biscuits. Cut each biscuit into 8 pieces; arrange evenly in dish.
- In large bowl, beat eggs, milk, mustard, salt and pepper with wire whisk until well blended. Stir in ham, onion, cheeses, mushrooms and cooked broccoli & cheese sauce. Pour mixture over biscuit pieces in dish. Press down with back of spoon, making sure all biscuit pieces are covered with egg mixture.
- Bake 40 to 50 minutes or until edges are deep golden brown and center is set. Let stand 10 minutes before serving. Cut into squares.
- High Altitude (3500-6500 ft): Heat oven to 375°F.
- Yield—8 servings.

Busy Day Barbeque Chicken

Ingredients:

4 boneless, skinless chicken breasts cut into strips
1/2 cup ketchup
1 (4 ounce) can tomato sauce
1 tablespoon brown sugar
1 teaspoon garlic powder
1 teaspoon onion powder
1 teaspoon dried mustard
1 teaspoon hot pepper sauce
1/2 teaspoon salt
1/2 teaspoon pepper
1 tablespoon Worcestershire sauce

Preparation:

- Place chicken pieces in bottom of Crock Pot cooker.
- Combine remaining ingredients and pour over chicken.
- Cover and cook on low for 8 to 10 hours.
- When almost finished, chicken can be shredded for serving on buns.

Southern Deep Dish Cobbler

Ingredients:

1 stick of butter
1 Cup of Sugar
1 Cup of Milk
1 Cup flour
1 Large can of peaches

Preparation:

Mix all the ingredients up in an oven-safe deep dish (like a 3 liter corning ware dish) and then pour the can of peaches in the middle.

Cook at 350 degrees until the crust is golden brown.

The mixture will cover the peaches as it cooks.

Top with vanilla ice cream and enjoy. Serves 4 to 6
